Session 1. Multiple labour relations and the process of commodification.

As shown by the transformations that have taken place in the last decades, both in the new areas of globalization and in the traditional locations of industrial society, the process of labour commodification is not necessarily linked to wage labour. The inputs stemming from global labour history, gender studies, post-colonial studies, and some reflections that already characterized the European historiographical tradition, help to reconsider (free/unfree, heteronomous/autonomous) labour relations beyond the 19th century model of the "wage society".
